Evaluation of the applicant's scholarly/artistic qualifications

Doc. MUDr. Libor Paša, Ph.D. is the first or correspondent author of 17 original works, of which 6 are in the impacted journal. In particular, the last publication is evaluated by a high Impact factor and is in the first quartile of the field of orthopedics. However, the applicant is also a co-author of another 29 publications, 9 of them again in impacted journals and some in prominent periodicals.

He is a frequent co-author of chapters in many professional books and has participated in a total of eight scientificall projects. The long-established scientific qualification will be most reflected in the citations received. Doc. MUDr. Libor Paša, Ph.D. was cited in the Web of Science database a total of 119 times, its current H index is 4.

Evaluation of the applicant's pedagogical experience

Since 2015, doc. MUDr. Libor Paša, Ph.D. teaches students of Medical Faculty of MU the subject Traumatology. The pedagogical experience is therefore great, which he further develops as a supervisor of doctoral students. He is currently studying five doctoral students under his supervision, and one has already finished his dissertation. Doc. Paša is an instructor

of trauma courses, including AO Interantional, is a member of examination commissions and a long-term organizer of national trauma congresses.

Doc. MUDr. Libor Paša, Ph.D. is a recognized expert in his field and at the same time a daily practicing physician - surgeon. Remaining in touch and repeatedly meeting prominent personalities in orthopedics and traumatology around the world, he has been vice president and president of the Society for Sport Traumatology and Arthroscopy since 2004, since 2015 he has been an honorary member of this company in Slovakia and won the award for the best EFORT poster in 2003. His personality combines a good balance of scientific care and perseverance, medical skills and diligence and human approach to both patients and students. Medical Faculty of MU in his person will get a very high quality professor in the field of surgery.

Conclusion: The applicant **is** a respected and recognized scholarly figure in his/her field. The applicant **has** made a significant contribution to the development of his/her field. The applicant **constitutes** a leading figure in his/her field of scholarship or research.
